1871—Property Tax for Mrs. Blaskey, owning same property as described above, a total of \$9.48.

1872—John Blaskey now paid the tax, a total of \$10.94.

1873—Again, John Blaskey paid the tax for the property listed as owned by Mrs Blaskey, and all the same property listed, with varying tax rates, but in relatively the same dollar area, until 1884, when John Blaska's taxes paid by John Blasky/per Hebel.

Hebels, Adlers, Skalitzky's still owned their property in Amherst in 1884.

It appears that 1874 was the last year the property was listed as owned by Mrs. Blaskey. In 1875, it was listed as owned by John Blaska.

The name was spelled in various ways throughout the years as Blaskey, Blaski, Blewski, Blaskee. In 1883, was the first appearance of the name having been spelled Blaska, as it is now spelled, and has been spelled for the past 75 ye
